This warranty covers all parts including the burrs and excluding the finish. This warranty is void if the mill is used commercially, or in any way other than recommended.

Bitterroot Tool & Machine will repair, or at its discretion, replace the grain mill or mill parts free of charge if in the opinion of the company it has been proven the problem is related to defective parts or an error in workmanship within the warranty period.

This is a Lifetime Warranty as defined in the Consumer Product Warranty and the Federal Trade Commission Improvement Act. It gives you specific legal rights; you may also have other rights that vary from state to state. See reverse for additional information.

Money-Back Guarantee: Your grain mill comes with a 30 day money-back guarantee. Contact Bitterroot Tool & Machine immediately to arrange return and full refund of purchase price if you are not satisfied with your purchase.

Registration: The Warranty Registration Card must be completed and mailed to Bitterroot Tool & Machine, PO Box 130, Stevensville, MT 59870, within thirty (30) days of receipt of merchandise. If you purchase a mill without a Warranty Registration Card, please contact Bitterroot Tool & Machine immediately. This proof of purchase must be on file with the company when requesting warranty service.

Limitations: The warranty is void if the product is used for any other purpose than that for which it is designed or intended. The product must not be altered, repaired or serviced by anyone other than the company. The product must not have been subject to accident or damage in transit, or while in the owner's possession, misused, abused or operated contrary to the instructions contained in the instruction manual. This warranty is valid in all countries. The consumer will pay all postage for repairs if shipping outside the United States.

Shipping Damage: Damage due to shipping should be reported immediately to the carrier. Damage caused in shipping is not the responsibility of Bitterroot Tool & Machine.

Warranty Claims: You must receive verbal or written authorization from Bitterroot Tool & Machine to return the mill, burrs, or any other defective part. Authorization can be obtained by calling the number below. Returned mills or mill parts must be shipped freight prepaid to Bitterroot Tool & Machine. The return shipping cost to the consumer will be the responsibility of Bitterroot Tool & Machine for all parts or mills returned to United States addresses.

Expressed or Implied Warranties: Except to the extent prohibited by law, no other warranties whether expressed or implied, including warranty merchantability and fitness for a particular purpose, shall apply to this product. Under no circumstances shall Bitterroot Tool & Machine be liable for consequential damages sustained in connection with said product. Bitterroot Tool & Machine neither assumes nor authorizes any representative or other person to assume for it any obligation or liability other than such as is expressly set forth. This warranty covers only the GrainMaker® and its specific parts, not the food or other products processed in it.
